Board Vacancy: The board accepted the resignation of long-time board member and community public servant Irwin Fust. He served the community well and in accepting his resignation the board posted the vacancy and called on the community to apply for the vacant seat. (See website for application).

General Manager Note: The Board approved a fiscal year 2024 budget in an updated format - check it out on the website. The District is looking to modernize many of its functions and is moving forward with a new customer billing system. This will replace an older system and provide more customer service with online account usage information, payment options, ebills, direct and area specific customer communications and much more. The District received a grant to upgrade the wells and booster station electrical and SCADA systems. This project is moving forward, and we expect to be installing the upgrades in the fall. The District also received a grant for the Treatment plant backwash ponds improvements - from both the State and FEMA. The State portion has started while we wait for final allocations from the FEMA side. This is longer term project that will take a few more years prior to construction. With increased office staff time we are working hard to clean up the customer database, help customers with payment assistance programs, work on delinquent accounts, identify lockouts, handle phone calls and more.
