*Minutes from January 15, 2019**Next BOD Meeting ~ February 19, 2020*

OPEN TIME:

Consent Agenda: A motion was made and seconded to approve the minutes of November 20, 2019 and to approve Financial Statements and paid bills from 11/25/19-12/31/19. Motion voted on and unanimously approved. **NEW BUSINESS:**

Doug Evans Resignation from the BOD – Ordinance 2020-01: Chairwoman Trenerry read Ordinance 2020-01 commending Director Doug Evans for his distinguished years of dedicated service to the District. A motion was made by Vice Chairman Fust and seconded by Director Engel. Motion was voted on an unanimously approved. WIIN Act ~ Exhibit C Language/Construction Cost Repayment: Manager asked the Board members if they've had a chance to review Exhibit C? All Board member agreed they have read it. Mr. Born stated that he had several conversations with multiple people about Exhibit C and at this stage we are not eliminating doing the ATP Study. We are looking at the word "Commercial" in the Exhibit and the definition of it. There is no definition of parcel size in the Exhibit, which leaves that wide-open and that is good. Mr. Born stated that one thing the Bureau of Reclamation is wanting to know from us, is if we are going with the ATP Study? Mr. Born stated that he told them that he had to consult with the Board Members first. Mr. Born stated that his recommendation is; not do the ATP Study because the construction component is going away. After a lengthy discussion, Mr. Born advised that we have to have an answer by February 28, 2020 because our current Study expires then. There is still a lot that needs to be looked at and reviewed before final decisions can be made. The topic will be discussed and an action made at the next BOD meeting in February.

CARB ~ Update on Dump Truck Status: Manager stated that we were the first person on their list when they started doing the retro's because I kept in touch with them to get this done. They came out but didn't accomplish the work because of one thing or another. They are coming back later this month. It's just postponed, we are still at the top of their list.

Rate Study ~ RCAC: Manager advised the progress with the rate study is moving forward. There are still a lot of things that need to be worked out. RCAC is advising we should be billing by meter size, there are some issues we have with that so we are still working diligently to get all the kinks worked out so that we can have a meeting between the BOD and RCAC and have everything in order.

FEMA ~ Backwash Pond Repair: Manager stated that we are back on track again as far as getting some funding from FEMA. Mr. Born stated that he got a phone call on Monday from his now 5th Program Manager and our project is back in their research center in Texas. We had our engineers re-write the report to take other things into consideration and initially the people in Sacramento seemed satisfied and JPIA has been kept abreast, just in case things fall through again. Director Engel asked Mr. Born if JPIA sent out an employee to look at the ponds? Mr. Born stated yes, the representative works for McLarens, which is the underwriter for JPIA. Mr. Born stated that JPIA has been nothing but stellar throughout this whole process and he has zero complaints about the JPIA or their underwriters. Mr. Born stated that he has also requested assistance from LaMalfa's office with the FEMA funding.

OPERATIONS & ADMINISTRATION:

Staff Reports: Manager stated he received a phone call, someone in Igo/Ono requesting a fire hydrant be placed in the middle of town with Clear Creek services. General Manager Born stated that the Tierra Robles project is still moving forward. Mr. Born has been in contact with someone who barters and sells water for agencies across the State of California. He is currently working with the Tierra Robles project. Mr. Born stated that he plans to solicit him to help Clear Creek sell our excess water. Mr. Born also advised that Dollar General has contacted us again, this time with a location next to Bonney's Burgers. We are also still working with RCAC as part of the Rate Study, on getting funding for the replacement of valves, main lines and meters.

The California Irrigation Management Information System (CIMIS) is a program unit in the Water Use and Efficiency Branch, Division of Statewide Integrated Water Management, California Department of Water Resources (DWR) that manages a network of over 145 automated weather stations in California. CIMIS was developed in 1982 by DWR and the University of California, Davis (UC Davis). It was designed to assist irrigators in managing their water resources more efficiently. 
REMINDER
