Minutes from January 16, 2019 ~ CCCSD Board Meeting

OPEN TIME:

Consent Agenda: A motion was made and seconded to approve the minutes of November 14, 2018 and to approve Financial Statements and paid bills from 11/26/18-1/10/19. Motion voted on and unanimously approved.

NEW BUSINESS:

Elections of Officers: Vice Chairman made a motion, which was seconded by Director Bassham, to appoint Johanna Trenerry as Chairwoman. Director Engle made a motion to appoint Irwin Fust as Vice Chairman and Director Bassham seconded these motions. Motion was voted on and unanimously approved. Director Engel stated that he believes it is important for someone to attend the ACWA conference in Monterey this year because of the State's water situation. Committee appointments were agreed upon by all Directors; Executive: Johanna & Irwin, Finance: Virginia & Doug, Legislative: Johanna & Irwin, Personnel: Virginia & Doug, ACWA/JPIA Representative: Mark & Johanna, Steering Committee: all members, Agricultural: Johanna & Doug.

WIIN Act ~ Update ~ Rescind Ordinance 2018-13, Adopt Ordinance 2019-01: Manager advised, in order to comply with USBR, we are rescinding 2018-13 and adopting 2019-01 in order to add Mark Engel's name. A motion was made, voted on and unanimously approved to adopt Ordinance 2019-01. The WIIN Act Contract Conversion Negotiation Session schedule is on March 13, 2019, from 10am-3pm in Sacramento, Ca.

State Resources Long Standing Water Rights Fee Law Suit: Manager advised the payments for water right fees have been made since 2003 for approximately \$8,000.00 a year. After several petitions, a judge decided that all water agencies will pay this fee. The case was dismissed and we will continue to have to pay. Manager advised the BOD that he continues to send letters of protest every year. Chairwoman advised she is concerned about the increase of taxes and fees as hers personally have tripled. Vice Chairman and Chairwoman both intend to visit our State Representatives for further discussion.

Debris Removal ~ **USBR Planning:** Manager advised the progress with repairs is slow at the Filter Plant due to other contractors being busy with other fire related work. He further advised that our assistance application for debris removal with the USBR has been approved. An on-site appointment with the USBR is set up for next Tuesday/Wednesday to start the process. Manager advised that the tree removal estimate was requested by FEMA and any tree removal expense not covered by the USBR or our Insurance, will be covered by FEMA.

Water Quality ~ Turbid Waters: Manager asked Treatment Plant Operator William Palmaymesa to explain the turbid water. Mr. Palmaymesa advised that since the last BOD Meeting, there has been more rainfall and the turbidity has increasing but he has been able to handle it with ease. He further advised the BOD that the tributaries feeding the lake are turning to muck but are getting better by the time the water reaches the Filter Plant. Chairwoman Trenerry asked Mr. Palmaymesa if he expects any problems with the upper draw and he replied that he would like to say no but if there are any mudslides, it will be a different story.

OPERATIONS & ADMINISTRATION:

Staff Reports: Assistant Manager advised the field crew has been doing routine checks, meter readings and work orders. 84 backflows were tested and 14 did not pass. Letters have gone out to those customer's to get the repairs done. We have been lucky to not have any main line leaks lately. He attended a Scoping Meeting in regards to the raise of the Shasta Dam and the meeting was very informative and the Government is being very aggressive about getting that project started. Assistant Manager advised he sent a letter to the USBR regarding the separation of the M&I and Agricultural side of the Construction Cost Index so it would help the District lower the repayment fee for the WIIN Act and the USBR sent us back a letter denying this request. He is currently working on the rate analysis study for rate increase and will have more accurate numbers by the next BOD Meeting.

***CIMIS ***

The California Irrigation Management Information System (CIMIS) is a program unit in the Water Use and Efficiency Branch, Division of Statewide Integrated Water Management, California Department of Water Resources (DWR) that manages a network of over 145 automated weather stations in California. CIMIS was developed in 1982 by DWR and the University of California, Davis (UC Davis). It was designed to assist irrigators in managing their water resources more efficiently.
