CIMIS

The California Irrigation Management Information System (CIMIS) is a program unit in the Water Use and Efficiency Branch, Division of Statewide Integrated Water Management, California Department of Water Resources (DWR) that manages a network of over 145 automated weather stations in California. CIMIS was developed in 1982 by DWR and the University of California, Davis (UC Davis). It was designed to assist irrigators in managing their water resources more efficiently. Our Treatment Plant Operators spent a couple of days/nights up at the Plant making sure we never did without water here in the Valley. We know it was a trying time and want everyone to know how much we appreciate all of you for your patience and understanding with the boil water alerts, no one to tend the office and maybe a little slower response time in getting to calls due to all of the snow. We are aware there were multiple service line breaks and if you need to make payments on your bill, please do not hesitate to call the office to make those arrangements. Also, if you have a HUGE bill and are seeking an adjustment on it, you must write a letter to the Board Of Directors requesting such. The Office Staff cannot make those decisions. Please address your letter to BOD and send it to the District Office. We will make sure they get and review them during the next BOD Meeting on March 20, 2019. We hope your clean-up process from the storm is not too long or hard. What a way to get us to prepare for the upcoming fire season!!

Water Allocation ~ 2019

The Bureau of Reclamation gave the initial allocation for water supplies for the 2019 water year. The Agriculture water allocation is 70% of historical use and the Domestic water allocation is 95%. With this information the District will NOT be imposing any water restrictions.
