The Board has been busy in this New Year

After early January rains, we are waiting to hear from the Bureau on their water year projections with early expectations of higher allocations than this last year, but still with restrictions.

The Board had a special meeting early in February to approve the new MOU for the District Employees. This is a significant step to bring the District employment practices current. Also, the MOU and all other employment documents are on the District website.

Water Restrictions and Penalties:

The CCCSD Board of Directors at the regular meeting in February reviewed the penalties and made no change to the current policy of penalties. In the coming months, the District will consider updating drought and water ordinances for the 2023 water year.

A message from your General Manager:

We are pleased to have more new employees at the District – we have a new Distribution Operator who joined the Team in February. Iam also pleased that the Board approved proceeding with some District IT (Computer) upgrades needed to start replacing older technology. The Board also approved proceeding with a State Grant to provide electrical repairs to the District's well and booster systems. Drought Restrictions & Penalties

Please be aware that penalties are in place for water over usage. The State and Bureau still consider us in a drought. You are allotted 75 % of your 2019 monthly usage OR 40 units / HCF whichever is greater.

The Board reviewed this at the February meeting, and kept the penalties in place for this month. If you go over your allotment, you will still be notified.

1 unit / HCF = 748 gallons

Reminder of the Penalties schedule:

< 5 HCF	\$50
5.1 – 10 HCF	\$100
10.1 – 20 HCF	\$400
20.1 – 50 HCF	\$600
50.1 – 100 HCF	\$800
>100 HCF	\$1,500

Meter Reading Dates

You can contact the office to get your meter reading but please give the staff a few days after the meter reading dates to get all reads downloaded and input into the software. You can also read your meter yourself in order to keep track of your usage.
