## What's new

**August 16th Board meeting moved to August 30th:** The Board was not able to meet at its regularly scheduled date and time and will take up the Board vacancy, adoption of updated policies, and other items August 30th when this newsletter is printed.

**Reminder:** Water Available - No Restrictions & No Penalties and all customers can use as much water as they can afford.

**General Manager Note:** As the District is looking to modernize many of its functions, we have signed a contract for a new customer billing system. The conversion is in process and the staff is working hard to clean up the database and help customers with payment assistance and looking to implement the new software in the coming months. This new system will have more online account usage information, payment options, e-bills, direct and area specific customer communications and much more. The South Booster/Wells SCADA grant project is proceeding for construction this fall. The other Grant projects (Treatment plant backwash ponds, and meter upgrades) are still proceeding.

We get questions about the fees on the bills - This month: WIIN Act Fee. The district signed an agreement with the Bureau to pay off the long-term capital obligation at once and convert the Bureau contract into 15,300 Acre Feet a year in perpetuity. That cost the district \$651,500 and this \$1.88/Month fee pays this off in approximately 14 years.

#### Full Water Allocation – Rates report:

**Reminder: The Base rate** is \$57.11 plus water usage and fees. Make sure to pay on time - A **Late Fee** of **1.5%** will be applied to accounts who have not paid their bill by **the 20th of each month**. The District sent hundreds of delinquent and shut off notices (60 days plus late in payments) - with hundreds making payments or getting payment assistance. **If you need payment assistance -** Programs are available.
